



**MEMORANDUM OF UNDERSTANDING
BETWEEN
YOGYAKARTA STATE UNIVERSITY, INDONESIA
AND
RAJAMANGALA UNIVERSITY OF TECHNOLOGY PHRA NAKHON, THAILAND**

This Memorandum of Understanding (hereinafter referred to as MoU) is made on this 12th day of October 2017 by and between Yogyakarta State University, Indonesia and Rajamangala University of Technology Phra Nakhon, Thailand.

Yogyakarta State University and Rajamangala University of Technology Phra Nakhon have agreed to cooperate based on mutual trust and benefit for purpose of developing two universities and promoting international exchange and cooperation.

ARTICLE 1

Objective

The objective of this MoU is to develop and promote ties between both universities and to promote academic exchange between the two countries.

ARTICLE 2

Scope of Cooperation

Both Yogyakarta State University and Rajamangala University of Technology Phra Nakhon agree to try to do the following cooperation:

1. Exchanges of faculty and administrative staff;
2. Exchanges of students;
3. Exchanges of research materials, publications, reports, and other academic information;
4. Collaboration and research projects;
5. Joint publications;
6. Any other academic activities beneficial for both universities.

ARTICLE 3

Plan of Action

A detailed description of every cooperation will be defined in separate documents, which shall be drawn up and agreed upon by Yogyakarta State University and Rajamangala University of Technology Phra Nakhon.

ARTICLE 4
Financial Arrangement

The two institutions understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.

ARTICLE 5
Duration and Termination

1. This agreement will come into effect when signed by the representatives of both institutions and will have duration of five (5) years.
2. Extensions and/or modifications may be made as agreed in writing by both parties.
3. Each party may cancel this agreement by providing the other with a written notice six (6) months prior to the date of cancellation.

ARTICLE 6
Notices

Every notice, request or any other communication required or permitted to be given pursuant to this MoU shall be in writing and delivered to the Parties at their addresses stated below:


