As the FHR will be the Center of Bavarian-Thai Universities Cooperation, the two institutions hereby agree to the following:

1. The purpose of the cooperation is to enable RMUTP to develop and to delivery industry relevant curricula in those fields as mention above, and to provide a platform for technology transfer between Germany and Thailand.
2. Visiting of academic and technical staff, as well as graduate students, to each institution will be encouraged in connection with (1) Such visits can be of a short- or longer-term nature, and can be for the purposes of (2)consultation,(3)participation in teaching/training activities, and (4)conducting research.
3. FHR will assist RMUTP in the training of the academic staff through admission of suitably qualified candidates to the FHR's postgraduate programs of study.
4. Student exchanges at all levels should be encouraged in both directions. The terms and conditions of such exchanges should be negotiated and agreed upon by the two parties.
5. The two parties will try their best, either unilaterally or jointly, in securing financial support from relevant funding agencies for the fulfillment of the activities outlined above.

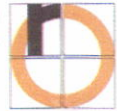
