On Academic Collaboration

This memorandum of understanding (MOU) is completed at Rajamangala University of Technology Phra Nakhon on the 9 March 2018 The MOU expresses a cooperation between the Rajamangala University of Technology Phra Nakhon (RMUTP) located at 399 Samsen Road, Vajira Payaban, Dusit, Bangkok 10300, Thailand, which will be subsequently called "Rajamangala University of Technology Phra Nakhon" by Associate Professor Supatra Kosaiyakanont, the President, and the Cambodia Professional Organization (CPO), located at No. 20 E2z Ro..134, Sangkat Monorom, 7Makara, Phnom Penh, Cambodia, which will be subsequently called the "Cambodia Professional Organization" by Dr. Dara SAT, the Board of Directors.

Rajamangala University of Technology Phra Nakhon, Kingdom of Thailand and the Cambodia Professional Organization, Kingdom of Cambodia hereinafter referred to as the "Parties" have agreed to promote academic collaboration. The Parties have reached the agreement as follows:

1. The Parties shall encourage the following activitieses:

Academic Aspects

- 1.1 Develop program and learning processes;
- 1.2 Develop curriculum and organize field trips/workshops to promote sharing-and-learning among professors and students;
- 1.3 Participation in seminars, academic meetings, symposiums and lectures;
- 1.4 Extension of students' learning opportunities;
- 1.5 Exchange of faculty, staff members and students;
- 1.6 Enroll alumni and students, who aim to extend their degrees;
- 1.7 Provide scholarships or grants to faculties, students and alumni, who aim to extend the degrees;

Research and Development Aspects

- 1.8 Joint research activities;
- 1.9 Provide resources for research such as research sites, research resources, research information, grants, or laboratories;
- 1.10 Co-host a national or an international conference;

Other Aspects

- 1.11 Provide resources for technology transfers and academic services;
- 1.12 Exchange of academic materials and others information;
- 1.13 Other educational and academic collaboration which exchange as approved by the two parties.
- 2. Specific agreements or Memorandum of Understanding for implementing this Memorandum of Understanding shall be signed separately after negotiation on the detailed programs between the Parties.

- 3. All activities resulting from this Memorandum of Understanding shall be governed by and in accordance with the laws and regulations of the Kingdom of Thailand and the Kingdom of Cambodia. All agreements and obligations of the Parties are subject to the procurement and maintenance of all applicable government consents, permits, authorizations, and approvals.
- 4. This Memorandum of Understanding shall be governed in accordance with the law and regulation of the Kingdom of Thailand and the Kingdom of Cambodia as well.
- 5. This Memorandum of Understanding is valid for five years and may be revisable or extendable by mutual consent. Either party may terminate the Memorandum of Understanding at any time by written notice signed by the appropriate official of the party initiating the notice. The notice must be received by the other party at least six months prior to the effective date of termination. The termination of this Memorandum of Understanding will not affect the implementation of on-going activities and/or programs undertaken pursuant to this Memorandum of Understanding, prior to the date of termination of this Memorandum of Understanding unless otherwise jointly decided upon by the Parties.
- 6. Any dispute or differences arising out of the interpretation or implementation of this Memorandum of Understanding shall be settled amicably through consultation between the Parties.
- 7. This Memorandum of Understanding shall be effective, when the representative of the Parties have affixed their signatures.

The information, permission, or agreement under this MOU must be communicated by an official letter.

There are two copies of this MOU with the same wording that both parties have thoroughly read and understand, and agree on all the purposes. Therefore, both parties sign and stamp (if any) it for further reference.
