



Research Agreement

This Agreement is entered into by and between the Dean of Faculty of Business Administration, Rajamangala University of Technology Phra Nakhon (RMUTP), located at 86 Phitsanuloke Road, Dusit, Bangkok 10300, Thailand, (hereinafter referred to as "RMUTP") and Head of Research and Community Services Center, located in the Bali State Polytechnic, Bali, Indonesia (hereinafter referred to as "BSP")

Whereas, BSP has applied to RMUTP to enter into research collaboration, and agrees to the conditions placed upon BSP in this agreement and to comply with the principles set forth therein; and

Whereas, RMUTP agrees to do such research collaboration; now therefore, in consideration of the mutual cooperation and condition contained herein, the parties hereto understand and agree as follows:

Section 1: Parties Bound.

The provisions of this Agreement shall apply to and be binding upon RMUTP and BSP

Section 2: RMUTP Authorization

RMUTP hereby authorizes BSP to undertake part of the research work as mentioned in the agreed research proposal in the Faculty of Business Administration, Rajamangala University of Technology Phra Nakhon (RMUTP), Bangkok Thailand on the subject of "*Culture-based Creative Economics for Social Welfare Development*".

Section 3: Conduct of Research Collaboration

RMUTP and BSP have primary responsibility to perform and supervise the research project and shall have sole control over the manner in which the Research Project is conducted

Section 4: Responsibilities of RMUTP and BSP

In accordance with the research collaboration as in the agreed project proposal, RMUTP and BSP can visit and also share data with each other.

Section 5: Research Result

Ownership : Rajamangala University of Technology Phra Nakhon (RMUTP) will own all rights, titles to and interests in any and all research results that are created, conceived of, reduced to practice or authored solely by RMUTP, Rajamangala University of Technology Phra Nakhon (RMUTP and Bali State Polytechnic will jointly own all rights, titles to and interests in any and all research results that are created , conceived of, reduced to practice or authored jointly by RMUTP and BSP ("Joint Research Results"). Bali State Polytechnic will own all rights, titles to and interests in any and all research results that are created, conceived of, reduced to practice or authored solely by BSP.

Disclosure: Each party will disclose its Research Results to the other party as soon as possible after receiving a written disclosure or similar notice of Research Results from its inventors. Inventors of Joint Research Results shall jointly prepare a disclosure of results and submit it to their employer.

Section 6: Publication Rights

Prior to submission for publication or public presentation of a manuscript or abstract describing the results of the Research Project, the publishing party will send a copy of the proposal manuscript or abstract to the other party. Within fifteen (15) days of the other party's receipt of the manuscript, the other party shall identify, in writing, for the publishing party specific information in the manuscript that the other party identifies as patentable or the other party's Confidential Information. If the other party identifies patentable information, it will also notify the publishing party in what countries the non-publishing party intends to seek patent protection.

Section 7: Non-commercial Purpose

BSP hereby warrants that no research performed under this Agreement and no research products will be used for commercial purposes, unless otherwise provided for in this agreement.

Section 8: Terminate Agreement.

This agreement may be terminated by:

- (a) The mutual agreement of both parties in writing; or
- (b) Either party giving the other not less than ninety (90) days advanced notice of termination
