为推动甲乙双方国际化办学,在"一带一路"的教育政策指引下, 本着合作共 赢、优势互补,携手共创的合作原则,在平等自愿的基础上, 经双方友好协商达成以 下合作意向,双方共同遵守。

In order to promote the internationalization of the two parties, under the guidance of national education policy of "Belt and Road", based on the principle of win-win Cooperation and complementary advantage, the two parties have reached the following understanding through full discussion and friendly consultation.

一、合作内容:

双方将依托各自优势教育资源开展全方位的合作:

- (1) 实施双方互派留学生访学游学项目(具体协议另行规定);
- (2) 实施师资互聘共享制度,互派师资交流、授课,共同开展科研项目(具体协议另行约定);
 - (3) 联合举办国际性创新创业基地、实习就业基地;
- (4) 联合举办中泰国际合作学术论坛;
- (5) 联合举办国际性大学生专业技能大赛等。
- (6) 为双方组织的国际旅游教育主题峰会、研讨会、国际技能竞赛提供便利条件。

1. Cooperation on Consensus

The two parties will rely on their resources to conduct all-round

cooperation for all majors as follows:

- (1) Implement exchange programs between students of both parties (specified by specific agreement).
- (2) Implement the mutual recruitment and sharing system to exchange teachers and exchange classes, develop academic research projects (specified by specific agreement).
- (3) Jointly organize international innovation and entrepreneurship bases and internship placement bases.
- (4) Jointly organize the China-Thailand International cooperation Academic Forum.
 - (5) Jointly organize international student skills competitions.
- (6) Facilitate the international tourism education theme summits, seminars and international skill competitions.

二、合作期限

此协议有效期5年。协议到期前三个月,如双方一致认可可以继续合作,可 正式续签书面续约协议。

2. Cooperation on Duration

This agreement is valid for 5 years. Three months before the expiration of the agreement, if both parties agree that they can continue to cooperate, the written renewal agreement can be formally renewed.

三、协议的变更

本协议未尽事宜,或需变更,需经双方共同协商,做出书面补充协议,补充协议与本协议具有同等法律效力。

3.Terms and conditions

If the agreement is not completed or needs to be changed, a written supplemental agreement shall be made through mutual agreement between the two parties. The supplemental agreement has the same legal effect as this agreement.
