



Memorandum of Understanding

between

Rajamangala University of Technology Phra Nakhon

and

Korea Invention Promotion Association(KIPA)

Preamble

In furtherance of their mutual interests in the fields of education and research including invention promotion and the commercialization of invention, Rajamangala University of Technology Phra Nakhon and Korea Invention Promotion Association(KIPA) hereby agree upon the following areas of cooperation:

- To engage in joint efforts in research including innovation, invention and consultancy on agreed topics of common interest;
- To develop the exchange of research including innovation, invention and academic staff mobility in a short period and long period with a view of promoting learning and culture and fostering close friendship between the two organizations on the basis of principles of mutual benefit and equality.

This collaboration will be developed between appropriate Schools, Universities, Departments and Units at the two organizations specified in the agreements which are linked to this Memorandum of Understanding(MoU).

Article 1

The parties shall cooperate in the development of human resources in the field of intellectual property including training and teaching, training of trainers, and sharing of ideas and experiences in this sphere through traditional forms such as seminars, workshops, roundtables and through new methods such as distance learning, video conferences, etc.

Article 2

The parties agree to encourage the exchange of scholarly and educational publications and materials, as well as biographical, reference and other pertinent literature. The exchange of periodicals and other publications will be carried out by the libraries of the two organizations based on mutual needs and interests.

Article 3

Each party agrees to invite representatives of the other party to participate in major congresses, conferences, symposium, exhibition, workshop and training of mutual interest. Each party shall provide mutual support for for participants mutually.

Article 4

This MoU does not exclude the possibility of organizing other forms of exchange or expanding this MoU should both parties so desire.

Article 5

Each party will nominate its own representative and such representative will be responsible for all measures to be undertaken under this MoU.

Article 6

This MoU shall come into effect on the day of approval by both organizations with a duration of five years. Either organizations may terminate this MoU provided that written notice of the intent is given at least six months prior to termination. Commitments already in progress shall be fulfilled.

Article 7

Amendments or changes to this MoU shall be made in writing and signed by the duly authorized representatives of the organizations.

Article 8

The MoU has been signed in duplicate, of which each organization will receive one copy.
