In accordance with their mutual interests in a program of cooperation and exchange, Bicol University in Philippines, Norton University in Cambodia, Suratthani Rajabhat University in Thailand, Ho Chi Minh City University of Transport in Vietnam, Universiti Putra Malaysia in Malaysia, Petra Christian University, Indonesia, Rajamangala University of Technology Phra Nakhon, Thailand, and Universitas Ciputra, Indonesia join this agreement with regard to educational and scientific cooperation.

All the universities have reached an accord on the following areas of cooperation, commencing on _____, subject to mutual consent and availability of funding:

1. Exchange of research scientists and faculty members
2. Exchange of students and credits
3. Exchange of academic materials and other information
4. Joint research activities
5. Participation in seminars and academic meetings
6. Special short-term training programs

The terms of such mutual assistance and funding for any specific program or activity shall be mutually discussed and agreed upon in writing by the Presidents or the authorized representatives of all universities before the initiation of that program or activity.

This agreement will take effect when it is signed by the Presidents or the authorized representatives of all the universities, and it will continue to be valid unless and until it is terminated by a written notice of any signatory party, or until three years has elapsed without successful implementation of the agreement.




