



## **Memorandum of Understanding**

This memorandum of understanding is signed at Rajamangala University of Technology Phra Nakhon on November 18, 2014 between Rajamangala University of Technology Phra Nakhon hereinafter referred to as RMUTP and IT Professional Co., Ltd. hereinafter referred to as IT Professional. The purpose of this memorandum of understanding is to create academic collaborations in order to support cooperative education program or vocational experience training program of Faculty of Home Economics Technology. Both parties hereby agree as follows:

### **Principle**

The National Education Act B.E. 2542 (1999) of Thailand focuses on the development and collaborative support between government and private sectors in order to create efficient education in producing human resources in accordance with the demands of business sectors. Faculty of Home Economics Technology, Rajamangala University of Technology Phra Nakhon has developed Bachelor of Home Economics Program (2007).

IT Professional, a food and beverage company, has seen the importance of manpower development to be skillful and competent to match the growing demands in the industry, IT Professional provides collaboration to RMUTP which is an educational institute producing effective hands-on graduates to support food and beverage industry.

## **Objectives**

To support and develop consistently and systematically the students of RMUTP in order to meet the demands of business sectors.

Both parties have agreed the provisions and conditions as follows:

### **1. Collaborations**

IT Professional shall provide collaboration to RMUTP in producing and developing students. The details are as follows:

- 1.1 provide cooperative education program to the students of RMUTP
- 1.2 provide vocational experience training program to the transferred students of RMUTP
- 1.3 offer jobs to the graduates of RMUTP
- 1.4 publicize the cooperative education program
- 1.5 attend related programs

The responsibilities belong to the committees consisting of the representatives of RMUTP and the representatives of IT Professional. The duty of the committees is to create policies and administration in accordance with this MOU

### **2. Responsibilities of the committees**

- 2.1 provide collaboration in curriculum development and cooperative education
- 2.2 provide collaboration in training program for instructors and academic staffs
- 2.3 provide collaboration by appointing supervisors for students, selecting co-op students and students of vocational experience training program in accordance with the duration and terms specified herein
- 2.4 provide collaboration in creating evaluation and monitoring criteria
- 2.5 provide collaboration in promoting the cooperative program in order to raise awareness of the outsiders about the cooperative education.


### 3. Duration

3.1 The collaboration commences from academic year 2014




### 4. Collaboration agreement

**Agreement and Procedures of Cooperative Education Program and Vocational Experience  
Training Program**

**The agreement of cooperative education program and vocational experience training program**

1. Faculty of Home Economics Technology of Rajamangala University of Technology Phra Nakhon shall select their students to attend the program.
2. IT professional Co., Ltd is able to select their staffs to attend the program for improving basic knowledge.

**The procedures of co-op students during semester**

1. Co-op students shall work consistently at IT professional Co., Ltd for 16 weeks.
2. Students of vocational experience training program shall work consistently at IT professional Co., Ltd for 8 weeks.
3. IT professional Co., Ltd shall pay students the expenses of accommodation, foods, travel, medical (in case of injury or illness), accident insurance and daily allowance during their cooperative education program in abroad.
4. IT professional Co., Ltd shall provide trainers or staffs for training students during the program.
5. Co-op students and students of vocational experience training program shall have a day off each week.
6. Co-op students and students of vocational experience training program shall follow strictly all regulations of IT professional Co., Ltd.
7. In order to create the knowledge specified in the curriculum, job rotation is needed.
