



Memorandum of Understanding

Between

Rajamangala University of Technology Phra Nakhon (RMUTP), Thailand

And

Bella Vista Institute of Higher Education (BVIS), Switzerland

This Memorandum of Understanding (MOU) is made and executed by and between Rajamangala University of Technology Phra Nakhon (RMUTP), is a public university located in Bangkok, where under the Ministry of Higher Education, Science, Research, and Innovation, Thailand, which located at 399 Samsen Road, Vachira Phayaban, Dusit, Bangkok, Thailand, represented by its President Dr. Natworapol Rachsirivatcharabul, duly authorized, hereinafter referred to as 'RMUTP',

and

Bella Vista Institute of Higher Education (BVIS), a private higher education institution in Switzerland that offers international academic programs and professional training in various fields, recognized for its commitment to global education and student mobility, which is located at St. Josefsweg 15b, 6460 Altdorf, Switzerland, represented by its Chairman of the Board, Mr. Rui Zhou, duly authorized, hereinafter referred to as 'BVIS'.

1. Objective

This MOU focuses on strengthening educational, cultural, and academic exchanges between Bella Vista Institute of Higher Education (BVIS), Switzerland and Rajamangala University of Technology Phra Nakhon (RMUTP), Thailand through the forms such as student and teachers exchange, and academic conference of both parties.

2. Areas of Cooperation

Both parties will encourage and promote co-operation in the following areas:

2.1 Exchange of students

- Both parties agree to facilitate student exchange programs to promote cultural and academic collaboration.
- RMUTP students will have opportunities to participate in exchange semesters in both Thailand and Switzerland under programs supported by the Partner.

2.2 International Programs and Dual Degrees

- The parties will collaborate on the development of International Programs at the RMUTP campus in Bangkok to attract International students.
- The Partner will provide possibilities for dual degree programs in collaboration with public universities in the United Kingdom in areas of mutual academic interest, including student mobility and institutional partnerships.

2.3 Exchanges of Teachers

- Both parties may send teachers or faculty members to deliver lectures, conduct research, and engage in academic collaboration.

2.4 Participation in Academic Conferences

- Both parties may jointly organize or participate in academic conferences, seminars, and workshops to enhance knowledge exchange and professional development.

3. Responsibilities of the Parties

3.1 Responsibilities of RMUTP

RMUTP will support and actively promote activities of exchange students and teachers, participate in academic conferences, and exchange of academic materials as outlined in areas of cooperation of this MOU.

3.2 Responsibilities of BVIS

BVIS will support and actively promote activities of exchange students and teachers, participate in academic conferences, and exchange of academic materials as outlined in areas of cooperation of this MOU.

4. Expenditures and Budgetary

Both parties agree that expenditures which may be incurred during the period of implementing this Memorandum of Understanding, the parties shall enter into discussions and negotiate case by case.

5. Effect of Memorandum of Understanding

This Memorandum of Understanding serves only as a record of the parties' cooperative intentions and does not constitute or create any legally binding or enforceable obligations, express or implied.

6. Confidentiality

Each party shall undertake to observe the confidentiality and secrecy of documents, information and other data received from or supplied to, the other party during the period of the implementation of this Memorandum of Understanding or any other agreements made pursuant to this Memorandum of Understanding.

7. Revision, Modification and Amendment

Either party may request in writing a revision, modification or amendment of all or any part of this Memorandum of Understanding within thirty (30) days prior to the mutual negotiation with the other party. Any revision, modification or amendment agreed to by the parties will be reduced into writing and will form part of this Memorandum of Understanding and come into force on such date as may be determined by both parties.

8. Termination

Either party may terminate this MOU by providing written notice of such termination to the other party within sixty (60) days prior to the date of termination. In the case of such termination, any activities currently underway shall be allowed to continue until their conclusion.

9. Duration

The term of this agreement shall be from the date of signing of the agreement and will remain in effect for five (5) years.


