THIS MEMORANDUM OF UNDERSTANDING (hereinafter referred to as the "MOU") is made on this _____ day of _____ 2022

BETWEEN

UNIVERSITI TEKNOLOGI MARA (hereinafter referred to as "**UiTM**"), an institution of higher learning established by the Universiti Teknologi MARA Act 1976 whose address is at the Chancellery, Universiti Teknologi MARA, 40450 Shah Alam, Selangor, Malaysia and shall include its lawful representatives and permitted assigns;

AND

RAJAMANGALA UNIVERSITY OF TECHNOLOGY PHRA NAKHON (hereinafter referred to as "**RUTPK**"), a body established under the University Act 2010 whose address is at Faculty of Industrial Textiles and Fashion Design, 517 Nakhon Sawan Road, Chitralada, Dusit, 10300 Bangkok, Thailand and shall include its lawful representatives and permitted assigns;

UiTM and RUTPK shall hereinafter be referred to singularly as "the Party" and collectively as "the Parties".

WHEREAS:

- A.** UiTM is an established University with a track record of educational excellence and research and with a dynamic programme of collaborative arrangements with many international counterparts.
- B.** RUTPK is an established University with the mission to provide educational excellence and apply the university resources for the development of the local community.
- C.** The Parties hereby agree to enter into this MOU to declare their respective intentions and to establish a basis of co-operation and collaboration with respect to the provision of consultancy and technical services upon the terms as contained herein.

THE PARTIES HAVE REACHED AN UNDERSTANDING as follows:

ARTICLE I OBJECTIVE

The Parties, subject to the terms of this MOU and the laws, rules, regulations and national policies from time to time in force, have agreed to enter into this MOU to collaborate in the area of textile science and technology, industrial textiles and fashion design with specific emphasis on capacity building, training and joint collaborations.

ARTICLE II AREAS OF CO-OPERATION

Each Party shall endeavour to take necessary steps to cooperate toward the provision of the following services for:

- a. capacity building, training, staff and student exchange, research and joint collaborations in of textile science and technology, industrial textiles and fashion design;
- b. any other areas of cooperation to be mutually agreed upon by the Parties.

For the purpose of implementing the co-operation in respect of any areas stated in paragraph 1 the parties will enter into a legally binding agreement subject to terms and conditions as mutually agreed upon by the Parties.

ARTICLE III FINANCIAL ARRANGEMENTS

This MOU will not give rise to any financial obligation by one Party to the other.

Each Party will bear its own cost and expenses in relation to this MOU.

ARTICLE IV EFFECT OF MEMORANDUM OF UNDERSTANDING

This MOU serves as a record of the Parties' intentions and except in relation to Article VIII (Confidentiality) herein, does not constitute or create, and is not intended to constitute or create, obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

ARTICLE V

NO AGENCY

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so as to constitute either Party as the agent of the other.

ARTICLE VI

EFFECTIVENESS AND DURATION

This MOU will come into effect on the date of signing and will remain in effect for a period of **two (02) years** or such further period to be mutually agreed between the Parties, whichever shall be the earlier.

In the event that this MOU expires or is terminated, neither Party shall have any claim against the other save and except for any antecedent breach.

ARTICLE VII

GOOD FAITH

UiTM and RUTPK agree that each Party shall do all things necessary and deal with one another in good faith to ensure that the collaboration is carried out and implemented in a coordinated, cost effective and professional manner for mutual benefit.

The Parties recognize that it is impracticable to make provisions for every contingency which may arise in the course of performance of the provisions hereof and accordingly declare their intention that this MOU shall operate between them with fairness and without detriments to the interest of any Party and that each Party shall use best endeavour to ensure that full effect is given to the terms of this MOU in the spirit in which it was agreed.

ARTICLE VIII

CONFIDENTIALITY

The Parties hereto shall hold in strict confidence all information, reports and any other sensitive information furnished by either Party to the other or all information in connection with this MOU.

Any such information shall not be disclosed to any third party without the prior written consent of the other Party first being obtained unless the disclosure of such information is necessary for the proper discharge of either Party's rights or

obligation under this MOU or in law or as required by governmental authorities or information which is already in the public domain.

ARTICLE IX

NOTICES

Subject as otherwise provided in this MOU, all notices, demands or other communications required or permitted to be given or made hereunder shall be in writing and delivered personally or sent by prepaid registered post or addressed to the intended recipient thereof at its address, or faxed to the facsimile number set out below (or to such other addresses, or facsimile numbers as any party may from time to time notify the others).

Any such notice, demand or communication shall be deemed to have been duly served (if given or made by facsimile) immediately or (if given or made by letter) 30 days after posting:

Each Party reserves the right for reasons of national security, national interest, public order or public health to suspend temporarily, either in whole or in part, the implementation of this MOU which suspension shall take effect immediately after notification has been given to the other Party.


